To: Shareholders of Revenir Energy Inc. (formerly Legacy Reserves Inc.)

Revenir currently anticipates cash net proceeds of one or more planned divestitures of certain Revenir assets to be distributed to shareholders in the near future (the "Anticipated Distributions"). The Anticipated Distributions are contingent in all instances upon the closing of such transactions and ultimate approval of the Anticipated Distributions by Revenir's Board of Directors.

Revenir currently plans to pay the Anticipated Distributions to shareholders via Direct Deposit, or check mailed to those shareholders who have not enrolled in Direct Deposit. If payment is made by check, a check will be made out to the shareholder's name of record for each individual account and will be mailed to the registered address of such shareholder as shown on the official rolls of Revenir's transfer agent, Broadridge Corporate Issuer Solutions, Inc. To receive your distribution and avoid any unnecessary delays, it is critical your address reflected in the Broadridge shareholder records is current or that you have enrolled in Direct Deposit.
